Purpose of Data Processing

Storage of Personal Data

Dutch Ultraskate follows this procedure for storing your personal data:

- An account will be created when you register for the Dutch Ultraskate. This account will contain the personal details mentioned above.
- Your account can be deleted at any time; however, a valid account must be maintained until after the event to participate.
- Your account will be deleted after the event.

- A digital copy of the invoice generated upon registration will be stored offline on an external hard drive for five years, as required by Dutch law.

Sharing of Personal Data with Third Parties

Dutch Ultraskate will not share your personal data with third parties unless required by law. The following data will be made public when race results are published on social media:

- First and last name
- Gender
- Nationality
